SAFETY POLICY

ALEATICA places safety as the top priority in its operations and when it comes to providing services for our users, workers, contractors, communities and first responders.

Our governing principles are to:

- Foment a safety culture that allows all of our operations and activities to be conducted in safe and healthy working conditions and to ensure compliance with the regulations.
- Look after the health of our workers and the safety of our stakeholders: users, workers, contractors, communities and first responders.
- Promote the participation of our workers in matters concerning prevention, and health and safety at all organisational levels.

To respect these principles we have established the following commitments:

- To look after the health of our workers and contractors and ensure that the conditions in the workplace are sound.
- Provide safe and healthy working conditions for the prevention of work-related injuries and health impairment.
- To provide the highest road safety standards within the context of excellence in the quality of our service to ensure the well-being of our users and the communities around us.
- To guarantee that safety results comply with the internal and external requirements of all rules, codes and legislation in force that apply in every country where we operate.
- To identify hazards and assess risks using ALEATICA's Health and Safety Management System in a way which enables such risks to be measured, reduced or eliminated as far as possible and thus achieve continuous improvement in our processes.
- To encourage consultation and the involvement of workers and set up appropriate lines of communication. All ALEATICA personnel, including that of companies associated through sub-contracting, will receive information, instruction, training and supervision so they can work in safety.
- To notify and manage any incidents and accidents that arise, with the aim of investigating their root cause and taking steps to reduce or avoid any recurrence of them.
